The amount of ₱4,907,700.00 representing Savings from Operations for Calendar Year 2018 is hereby appropriated as additional funding to supplement the AIP 2017 counterpart allocation for the Rehabilitation and Improvement of the Hilaitan-Trinidad Farm-to-Market Road, Guihulngan City, under the Philippine Rural Development Project (PRDP).


Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


