
“Be it enacted by the Sangguniang Panlalawigan that:


Section 1. The amount of ₱1,000,000.00 representing existing appropriation balance of the project Additional Appropriation for the Construction of Multipurpose Evacuation Center, Barangay Balaas, Bindoy, Negros Oriental, funded under the 2018 Provincial Disaster Risk Reduction and Management Fund is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated as Additional Appropriation for the Construction of Multipurpose Evacuation Center, Barangay Balaas, Manjuyod, Negros Oriental.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
