“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 8
(Series of 2019)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,000,000.00 and ₱400,000.00 representing current Personal Services Savings – Salaries and Wages (Regular) of the General Fund Including Hospitals and existing allotment balance available from the General Fund – Proper intended for the Provision for Presidential Visits including Visits of Foreign Dignitaries, respectively, are hereby reverted to the unappropriated balance of the General Fund.

Section 2. The amount of ₱1,400,000.00 is hereby appropriated from the unappropriated balance of the General Fund to cover the following activities:

Executive - Legislative Agenda ₱1,000,000.00
