“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Valente D. Yap, the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 14
(Series of 2019)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱900,000.00 representing existing allotment balance of the allocation for Repair and Extension of Flood Control Dike, Barangay Poblacion III, Tanjay City, under the Annual Investment Program for Calendar Year 2017 is hereby reverted to the unappropriated balance; the same amount is likewise appropriated for the Improvement of Multipurpose Building/Evacuation Center, Barangay Poblacion III, Tanjay City.


Section 2. The amount of ₱750,000.00, representing a portion of the Government Equity as of December 31, 2018, is hereby appropriated to cover the following expenditures under the Governor's Office:


Assistance for Individuals in Crisis Situation.....	₱550,000.00
Five (5) Job Order (July – December, 2019).....	200,000.00

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


