(Series of 2019)



"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱100,000.00 allocated for the Construction/Rehabilitation of Barangay Cangmating Health Center, Sibulan, under the Annual Investment Program for Calendar Year 2018 is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Construction of Comfort Rooms at the Barangay Cangmating Multipurpose Covered Court and Evacuation Center, Sibulan.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.

"Enacted, September 2, 2019."


