“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 30
(Series of 2019)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱819,219.20 TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱800,000.00 is hereby appropriated from the Income derived from Sale of Bid Forms – Bids and Awards Committee, to augment the current budget of same committee, to wit:

Travelling Expenses-Local.....	₱ 12,500.00
Training Expenses.....	100,000.00

Office Supplies Expenses.....	₱ 50,000.00
Advertising Expenses.....	10,000.00
Repairs & Maint.-Office Equipment.....	35,000.00
Repairs & Maint.-IT Equipment & Software.....	35,000.00
Other Maint. and Operating Expenses - Job Order.....	247,500.00
Projector.....	100,000.00
Computer Sets.....	210,000.00


Section 2. The amount of ₱19,219.20 is hereby appropriated from Savings from Operations as of December 31, 2018 to replenish the amount utilized to settle Telephone Bills for Calendar Year 2016 which was erroneously charged against the Special Education Fund (SEF).

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


