AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM WATER EXPENSES UNDER THE BUDGET FOR THE OPERATION/ADMINISTRATION OF THE PROVINCIAL INTEGRATED SKILLS TRAINING CENTER IN THE SUM OF ₱167,012.00 TO BE TAKEN FROM OTHER MOOE ITEMS.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Water Expenses under the budget for the Operation/Administration of the Provincial Integrated Skills Training Center in the sum of ₱167,012.00 to be taken from other MOOE items under the same budget, viz:



Traveling Expenses-Local.....	₱ 8,000.00
Electricity Expenses.....	130,000.00
Repairs and Maintenance.....	4,012.00
Insurance Expenses.....	10,000.00
Other Maintenance and Operating Expenses.....	15,000.00


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2020.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
