“Presented for consideration before the August Body was the letter of the Provincial Administrator dated November 10, 2020, transmitting Resolution No. 108, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds for item Electricity Expenses of the Native Chicken Upgrading Program under the budget of the Office of the Provincial Veterinarian in the amount of ₱40,000.00 to be taken from item Agricultural and Marine Supplies, per letter-request of Mr. Jaime C. Villaluz, Officer-In-Charge, same office;

“Funds having been certified as available by the Provincial Accountant per his certification dated September 14, 2020;

“On motion of Honorable Member Jose A. Baldado, seconded by Honorable Member Erwin Michael L. Macias and Honorable Member Estanislao V. Alviola, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 26
(Series of 2020)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM ELECTRICITY EXPENSES OF THE NATIVE CHICKEN UPGRADING PROGRAM UNDER THE CURRENT BUDGET OF THE OFFICE OF THE PROVINCIAL VETERINARIAN IN THE AMOUNT OF ₱40,000.00.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:



Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Electricity Expenses of the Native Chicken Upgrading Program under the current budget of the Office of the Provincial Veterinarian in the amount of ₱40,000.00 to be taken from the item Agricultural and Marine Supplies.



Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2020.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
