“Presented for consideration before the August Body was the letter of the Provincial Administrator, this province, dated November 10, 2020, transmitting Resolution No. 98, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds for item Other Supplies and Materials Expenses under the Regular Budget of the Canlaon District Hospital in the amount of ₱100,000.00 to be taken from item Repairs and Maintenance – Transportation Equipment, same budget;

“Funds having been certified as available by the Provincial Accountant per his certification dated November 3, 2020;

“On motion of Honorable Member Valente D. Yap, seconded by Honorable Member Adem B. Maxino, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 27  
(Series of 2020)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM OTHER SUPPLIES AND MATERIALS EXPENSES UNDER THE REGULAR BUDGET OF THE CANLAON DISTRICT HOSPITAL IN THE AMOUNT OF ₱100,000.00 TO BE TAKEN FROM ITEM REPAIRS AND MAINTENANCE – TRANSPORTATION EQUIPMENT.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Other Supplies and Materials Expenses under the Regular Budget of the Canlaon District Hospital in the amount of ₱100,000.00 to be taken from item Repairs and Maintenance – Transportation Equipment, same budget.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2020.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
