“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Repairs and Maintenance – Transportation Equipment under the budget of the Government Agricultural Development Center (GADC), Office of the Provincial Agriculturist, in the amount of ₱331,750.00 to be taken from item Fuel, Oil and Lubricants Expenses.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2020.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
