“Presented for legislative authorization before the August Body was Supplemental Budget No. 19 of the 20% Development Fund for Calendar Year 2020 in the amount of ₱1,000,000.00 to fund the Concreting of Barangay Farm-To-Market Road at Purok III, Barangay Mantuyop, Siaton;

“On motion of Honorable Member John T. Raymond, Jr., seconded by Honorable Member Estanislao V. Alviola, the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 39
(Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,000,000.00 TO FUND THE CONCRETING OF BARANGAY FARM-TO-MARKET ROAD AT PUROK III, BARANGAY MANTUYOP, SIATON.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,000,000.00 representing unexpended allocation for Road Concreting in Purok II, Barangay Mantuyop, Siaton, under the 20% Development Fund for Calendar Year 2019 is hereby reverted to the unappropriated balance; the same amount is likewise appropriated for the Concreting of Barangay Farm-To-Market Road at Purok III, Barangay Mantuyop, Siaton.



Section 2. This Appropriation Ordinance shall take effect immediately upon approval.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
