“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 46  
(Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱8,525,000.00 TO COVER THE GRANT OF PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) TO OFFICIALS AND EMPLOYEES AT ₱5,000.00 EACH.

*Original Party*

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱8,525,000.00 representing current Personal Services Savings – Salaries and Wages (Regular) including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the grant of Productivity Enhancement Incentive to officials and employees at ₱5,000.00 each.



Section 2. This Appropriation Ordinance shall take effect immediately upon approval.



Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
