“Presented for legislative authorization before the August Body was Supplemental Budget No. 26 of the General Fund for Calendar Year 2020 in the amount of ₱14,679,000.00 to cover the Grant of One-Time Service Recognition Incentive to officials and employees of the provincial government and COVID-19 Hazard Pay to Contract of Services and Job Order;

“On motion of Honorable Member Chester V. Lim, seconded by Honorable Member Estanislao V. Alviola and Honorable Adem B. Maxino, the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 47  
(Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱14,679,000.00 TO COVER THE GRANT OF ONE-TIME SERVICE RECOGNITION INCENTIVE (SRI) TO OFFICIALS AND EMPLOYEES OF THE PROVINCIAL GOVERNMENT AND COVID-19 HAZARD PAY TO CONTRACT OF SERVICES AND JOB ORDER.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱14,670,000.00 representing current Personal Services Savings – Salaries and Wages (Regular) including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the Grant of One-Time Service Recognition Incentive (SRI) to officials and employees of the provincial government at ₱10,000.00 each, pursuant to Administrative Order No. 37 dated December 18, 2020.

Section 2. The amount of ₱9,000.00 representing current Personal Services Savings – Salaries and Wages (Regular) including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the Grant of COVID-19 Hazard Pay to Contract of Services and Job Order – Mr. Roque N. Salmorin.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


