“Presented for legislative authorization before the August Body was Supplemental Budget No. 1 of the General Fund Proper for Calendar Year 2020 in the amount of ₱50,672,000.00 to fund expenditures to counter the COVID-19 Pandemic;

“On motion of Honorable Member Valente D. Yap, seconded by Honorable Member John T. Raymond, Jr., the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 2
(Series of 2020)

AN ORDINANCE APPROPRIATING THE SUM OF ₱50,672,000.00 TO FUND EXPENDITURES TO COUNTER THE COVID-19 PANDEMIC IN THE PROVINCE OF NEGROS ORIENTAL.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱50,672,000.00 representing Underestimated Internal Revenue Allotment of the General Fund Proper for Calendar Year 2020

and Savings from Operations under the General Fund as of December 31, 2019 is hereby appropriated for necessary expenditures relative to the COVID-19 Pandemic in the province, viz:

Disaster Relief Goods for Cities and Municipalities of the Province of Negros Oriental @ ₱2,000,000.00/city or municipality.....₱50,000,000.00; and


Food Expenses for three (3) Meals per day to 200 PNP Personnel for 14 days as part of the COVID-19 Provincial Incident Management System..... 672,000.00,


provided that said amounts shall be downloaded to each local government unit and the Philippine National Police, respectively, for COVID-19 related expenses. The same is subject to liquidation and to the usual accounting and auditing rules, regulations and policies.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
