“Presented for consideration before the August Body was the letter of the Assistant Provincial Administrator dated July 2, 2020, transmitting Resolution No. 31, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds in the amount of ₱88,557.49 for item Terminal Leave Benefits under the current budget of the Office of the Secretary to the Sanggunian to be taken from the item Mid-Year Bonus, per letter-request of Atty. Geoffrey P. Villahermosa, Provincial Secretary;

“Funds having been certified as available by the Provincial Accountant per his certification dated June 24, 2020;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Chester V. Lim, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 7
(Series of 2020)

AN ORDINANCE AUTHORIZING THE HONORABLE VICE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM TERMINAL LEAVE BENEFITS UNDER THE CURRENT BUDGET OF THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG IN THE AMOUNT OF ₱88,557.49.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Vice Governor is hereby authorized to augment the allocation for item Terminal Leave Benefits under the current budget of the Office of the Secretary to the Sanggunian in the amount of ₱88,557.49, to be taken from item Mid-Year Bonus, to cover the deficiency in the allocation for the Terminal Leave Benefits of Ms. Ophelia T. Ontal, former Administrative Officer III of same office.


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2020.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
