AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱17,040,000.00 TO FUND THE PURCHASE OF TWELVE (12) UNITS VENTILATOR AND TWELVE (12) UNITS CARDIO VASCULAR MONITOR.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱17,040,000.00 representing existing allotment balance of projects, declared as completed by the Provincial Engineer, is hereby

reverted to the unappropriated balance of the 20% Economic Development Fund; the same amount is likewise appropriated to cover the purchase of the following medical equipment:

12 Units Ventilator.....	₱11,040,000.00
