“Presented for consideration before the August Body was the letter of the Provincial Administrator, this province, dated September 23, 2020, transmitting Resolution No. 77, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds for item Medical, Dental and Laboratory Supplies Expenses under the current Regular Budget of the Bindoy District Hospital in the sum of ₱290,000.00 to be taken from other MOOE items of the same budget;

“Funds having been certified as available by the Provincial Accountant per his certification dated September 11, 2020;

“On motion of Honorable Member Valente D. Yap, seconded by Honorable Member Kurt Matthew T. Teves, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 16  
(Series of 2020)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM MEDICAL, DENTAL AND LABORATORY SUPPLIES EXPENSES UNDER THE CURRENT REGULAR BUDGET OF THE BINDOY DISTRICT HOSPITAL IN THE SUM OF ₱290,000.00 TO BE TAKEN FROM OTHER MOOE ITEMS OF THE SAME BUDGET.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Medical, Dental and Laboratory Supplies Expenses under the current Regular Budget of the Bindoy District Hospital in the sum of ₱290,000.00 to be taken from other MOOE items of the same budget, viz:

Traveling Expenses-Local.....	₱70,000.00
Training Expenses.....	80,000.00
Accountable Forms Expenses.....	50,000.00
Telephone Expenses.....	10,000.00
Internet Subscription Expenses.....	40,000.00
Repairs & Maint.-Machinery & Equipt.....	20,000.00
Insurance Expenses.....	20,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2020.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
