“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Manuel L. Sagarbarria, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM TERMINAL LEAVE BENEFITS UNDER THE CURRENT BUDGET OF THE NEGROS ORIENTAL PROVINCIAL HEALTH OFFICE IN THE AMOUNT OF ₱994,934.70.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Terminal Leave Benefits under the current budget of the Negros Oriental Provincial Health Office in the amount of ₱994,934.70 to be taken from the item Salaries and Wages – Regular Pay to cover the Terminal Leave Pay of the following health personnel:

Ms. Vivien C. Vallega, former Nurse II.....	17,121.68




Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


