AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM FIDELITY BOND PREMIUMS UNDER THE BUDGET OF THE PROVINCIAL TREASURER’S OFFICE IN THE SUM OF ₱250,000.00 TO BE TAKEN FROM OTHER MOOE ITEMS OF THE SAME BUDGET.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Fidelity Bond Premiums under the budget of the Provincial Treasurer’s Office in the sum of ₱250,000.00 to be taken from other MOOE items of the same budget, viz:

Traveling Expenses-Local.....	₱150,000.00
Training Expenses.....	100,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2020.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
