“Be it enacted by the Sangguniang Panlalawigan that:


Section 1. Section 2 of Resolution No. 1153, series of 2020, enacting Appropriation Ordinance No. 41 is hereby amended by changing item ‘1 Unit FWD Utility Vehicle, Double Cab, Dropside (4 x 4), Manual, 2.7 Diesel Engine’ under the current budget of the Office of the Provincial Agriculturist to ‘1 Unit FWD Utility Vehicle, Double Cab, Dropside (4 x 4), Manual, 2.5 Diesel Engine’.

Section 2. This Appropriation Ordinance shall take effect immediately upon approval.
