“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 12
(Series of 2021)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱680,000.00 TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱80,000.00 representing unexpended allocation for Hospital Beds with IV Stand, Mattresses and Bedside

Tables (4 Units) under the Regular Budget of the Mabinay Medicare Community Hospital for Calendar Year 2018 is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the purchase of the following equipment for said hospital:

Heavy Duty Air Cooler.....	₱23,000.00
Refrigerator, 8 Cubic (Inverter).....	18,000.00
ECG Machine.....	36,000.00
LCD Monitor, 19".....	3,000.00

Section 2. The amount of ₱50,000.00 representing unexpended allocation for Office Equipment – Fax Machine under the budget of the Office of the Provincial Auditor for Calendar Year 2016 is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for Office Equipment – Air Conditioning Unit for the same office.

Section 3. The amount of ₱550,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund, for the Enhancement and Customization of the Legislative Management Tracking and Information System of the Office of the Secretary to the Sanggunian, to wit:

Enhancement of the Legislative Management	
Tracking and Information System.....	₱500,000.00
Computer Set and Accessories.....	50,000.00


Section 4. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.

Section 5. This Appropriation Ordinance shall take effect immediately upon approval.



Section 6. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
