“Presented for consideration before the August Body was the letter of the Provincial Administrator dated September 13, 2021, transmitting Resolution No. 78, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds in the amount of ₱36,000.00 for item Telephone Expenses under the current budget of the Office of the Clerk of Court, to be taken from item Training Expenses to cover telephone expense for the period from September to December, 2021, per letter-request of Atty. Maria Antonia L. Bulado, Clerk of Court VI;

“On motion of Honorable Member Jose A. Baldado, seconded by Honorable Member Estanislao V. Alviola, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 19
(Series of 2021)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM TELEPHONE EXPENSES UNDER THE CURRENT BUDGET OF THE OFFICE OF THE CLERK OF COURT IN THE AMOUNT OF ₱36,000.00.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Telephone Expenses under the current budget of the Office of the Clerk of Court in the amount of ₱36,000.00 to be taken from item Training Expenses, to cover telephone expense for the period from September to December, 2021.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
