AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEMS DRUGS AND MEDICINES EXPENSES AND MEDICAL, DENTAL AND LABORATORY SUPPLIES EXPENSES UNDER THE CURRENT REGULAR BUDGET OF THE MABINAY MEDICARE COMMUNITY HOSPITAL, TO BE TAKEN FROM ITEM TRAINING EXPENSES IN THE SUM OF ₱80,000.00.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for MOOE items under the current Regular Budget of the Mabinay Medicare Community Hospital, to wit:

Drugs and Medicines Expenses	₱ 40,000.00
Medical, Dental and Laboratory Supplies Expenses	40,000.00,

to be taken from item Training Expenses of same hospital.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2021.
