AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM ELECTRICITY EXPENSES UNDER THE CURRENT REGULAR BUDGET OF THE CONG. LAMBERTO L. MACIAS MEMORIAL HOSPITAL, TO BE TAKEN FROM ITEMS TRAINING EXPENSES AND OTHER PROFESSIONAL SERVICES IN THE SUM OF ₱400,000.00.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Electricity Expenses under the current Regular Budget of the Cong. Lamberto L. Macias Memorial Hospital in the sum of ₱400,000.00 to be taken from the following items:

Training Expenses	₱ 75,000.00
Other Professional Services	325,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
