AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱6,400,000.00 FOR THE PURCHASE OF EIGHT HUNDRED (800) UNITS EMPTY OXYGEN TANKS FOR THE IMPLEMENTATION OF THE NEGROS ORIENTAL OXYGEN PLANT PLAN.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱6,400,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund for the Purchase of Eight Hundred (800) units Empty Oxygen Tank, 40 Liters, at
