RESOLUTION NO. 856

“Presented for consideration before the August Body was the letter of the Assistant Provincial Administrator dated November 3, 2021, transmitting Resolution No. 137, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds in the sum of ₱222,185.00 for items Water Expenses, Office Supplies Expenses and Electricity Expenses under the current budget of the Provincial Engineer’s Office to be taken from item Training Expenses, per letter-request of Engr. Franco C. Alpuerto, Provincial Engineer;

“Whereas, the allocation for Electricity Expenses under the Calendar Year 2021 budget of the Provincial Engineer’s Office is ₱1,147,650.00;

“Whereas, attached Allotment and Obligation Slip Listing show that Electricity Expenses incurred by the same office as of October 5, 2021 is only ₱327,442.95;

“Whereas, based on the highest monthly consumption (March, 2021 Billing), the balance of ₱820,207.05 is sufficient to cover electricity consumption by said office for the rest of the year;

“Funds having been certified as available by the Provincial Accountant per his certification dated October 15, 2021;

“On motion of Honorable Member Kit Marc B. Adanza, seconded by Honorable Member Estanislao V. Alviola, the Sangguniang Panlalawigan of

Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

**APPROPRIATION ORDINANCE NO. 43**  
**(Series of 2021)**

**AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEMS WATER EXPENSES AND OFFICE SUPPLIES EXPENSES UNDER THE CURRENT BUDGET OF THE PROVINCIAL ENGINEER'S OFFICE IN THE SUM OF ₱101,185.00.**

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for items Water Expenses and Office Supplies Expenses under the current budget of the Provincial Engineer's Office in the amount of ₱41,000.00 and ₱60,185.00, respectively, to be taken from item Training Expenses.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
