Richard R. Enojo, Provincial Warden;

“On motion of Honorable Member Peter Paul F. Renacia, seconded by Honorable Member Estanislao V. Alviola, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEMS ELECTRICITY EXPENSES AND OTHER MAINTENANCE AND OPERATING EXPENSES – JOB ORDER UNDER THE CURRENT BUDGET OF THE NEGROS ORIENTAL DETENTION AND REHABILITATION CENTER IN THE SUM OF ₱177,000.00.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for items Electricity Expenses and Other Maintenance and Operating Expenses – Job Order under the current budget of the Negros Oriental Detention and Rehabilitation Center in the amount of ₱150,000.00 and ₱27,000.00, respectively, to be taken from other MOOE items, to wit:


Training Expenses.....	₱100,000.00

Repairs & Maint. – Machinery & Equip.....	40,000.00



Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


